I do waive, release, absolve, indemnify, discharge, covenant not to sue, and agree to hold harmless the owners, organizers, sponsors, supervisors, instructors, participants, members, and persons involved in the operation of Motor City Irish Dance, LLC programs for any claims and damages arising out of injury or other loss to the Student or any member of his/her family whether as a participant in the activities or as a spectator. I understand that Motor City Irish Dance, LLC may update the terms and conditions of this agreement at any time and must provide me with written notification, either on paper or electronically, of any changes. I understand that student and full membership plans are charged monthly, regardless of how many weeks in the month (including holiday or break weeks). I understand that membership plans are not pro-rated and that the first payment is due in full on the day of the Student's first class. I understand that I have a 7-day grace period from the Student's first class to request a full refund of the first payment and must make this request in writing, either on paper or electronically, to Motor City Irish Dance, LLC. I understand that, after the grace period, subsequent monthly payments are due by the Student's first class on the 1st week of the month. I understand that failure to pay the monthly payment may result in the suspension of the Student from all classes and company activities until the monthly payment is rendered. I understand that I will not receive any refunds or credits if the Student is absent in a class, regardless of the reason. I understand that I may disenroll the Student at any time for any reason from any class and that I will not receive any refunds or credits as a result of this action. I understand that a notice to disenroll must be made in writing, either on paper or electronically, to Motor City Irish Dance, LLC. I also understand that Motor City Irish Dance, LLC must provide confirmation to me in writing, either on paper or electronically, that the notice has been received in order to complete the disenrollment. I understand that, on occasion, Motor City Irish Dance, LLC may take still pictures or video of the Student during classes or company activities. I understand that these pictures or videos are property of Motor City Irish Dance, LLC and that they may possibly be used in print, broadcast, or online without identifying the Student by name.
